**CALL TO ORDER AND PLEDGE OF ALLEGIANCE**

A regular meeting of the City Council of the City of Hidden Hills was duly held in the Council Chambers at the City Hall, 6165 Spring Valley Road, Hidden Hills, California 91302 on Monday, March 31, 2014 at the hour of 7:30 p.m. Mayor Steve Freedland called the meeting to order and presided thereover after leading the Council and audience in the Pledge of Allegiance.

The following then addressed Mayor Freedland, thanking him for his past year of service as Mayor: Los Angeles County Sheriff's Department/Lost Hills Station Lieutenant and City liaison Dave Thompson; Los Angeles County Fire Department Assistant Fire Chief Anthony Whittle and Community Services Representative Maria Grycan; Hidden Hills Community Association Board Member and City liaison Bret Katz; and City of Calabasas Council Member Fred Gaines.

Mayor Pro Tem Landon, on behalf of the entire City Council and staff, presented an engraved boxed gavel set to outgoing Mayor Freedland, after which Mayor Freedland made his remarks, followed by remarks from the other Council Members and staff. It was pointed out that during Mayor Freedland's term as Mayor, among other things, the City completed its first certified housing element, entered into a one-of-a-kind library agreement with the City of Calabasas and the Las Virgenes Unified School District, and continued to push for the undergrounding of overhead utilities.

**D. Selection of Mayor**

Upon MOTION of Council Member Siegel and seconded by Council Member Cohen, it was resolved to nominate Mayor Pro Tem Landon for the position of Mayor. As there were no other nominations, a unanimous vote was cast, naming Mayor Pro Tem Landon as the new Mayor.

**E. Selection of Mayor Pro Tem**

Upon MOTION of Council Member Freedland and seconded by Council Member Cohen, it was resolved to nominate Council Member Weber for the position of Mayor Pro Tem. As there were no other nominations, a unanimous vote was cast, naming Council Member Weber as the new Mayor Pro Tem.

**F. Remarks by Incoming Mayor and Mayor Pro Tem**

Mayor Landon said as the rookie, he hoped to hold a candle to the rest of the Council Members who have all served as Mayor, and appreciated their vote of confidence in him. He added that he loves this City as all the Council Members do, and was looking forward to this next year. Mayor Pro Tem Weber said he felt somewhat experienced in this position, which he held for three years in the past, and that he was always just a phone call away and happy to help a good Mayor whenever needed.
