MINUTES

1. **CALL TO ORDER**

The January 30, 2007 regular meeting was called to order at 7:43 p.m. by Chairman Jim Doran.

3. **APPROVAL OF AGENDA**

The agenda for the January 30, 2007 regular meeting was approved as submitted.

4. **APPROVAL OF MINUTES**

The minutes of the November 28, 2006 regular meeting and the December 26, 2006 regular meeting were approved as submitted.

5. **AUDIENCE**

There were no comments at this time.

6. **BUDGET**

It was noted that Traffic Safety funds were used to pay for all the new signs within the city.

7. **L.A. COUNTY ANIMAL CONTROL**

Activity reports for October, November and December were received and reviewed. There was a discussion regarding the large amount for the October billing.

8. **L.A. COUNTY FIRE DEPARTMENT**

Activity reports for November and December were received and discussed. It was noted that there were no incidents.

9. **L.A. COUNTY SHERIFF'S DEPARTMENT**

The activity reports for November and December were received and discussed. Staff will be asked to check the location of a high speed violation, and to determine what "PDO" refers to regarding hit and run collisions. There was a discussion regarding the use of cameras for traffic monitoring. This will be discussed at the February meeting.

10. **NEW BUSINESS**

11. **EMERGENCY SERVICES**

Commissioners were asked to review materials that Chairman Doran brought for discussion at the February meeting. These included Spontaneous Volunteer Management Plan, An ADA Guide for Local Governments, and the Modified Mercalli Intensity Scale.

A CAN incident report was reviewed. These phone numbers are updated two times a year using the Community Association's reverse numbers. The Commissioners discussed phones and the satellite capability at City Hall, the Community Center, and Round Meadow Elementary School. Commissioner Weber will investigate and report back.

Residents should be encouraged to attend CERT training in March, as twenty (20) additional NEAT members are needed. To accomplish this, several suggestions were made: place notices at the Community Center and City Hall, along with a flyer explaining NEAT; notify all the clubs within the City; make a short video regarding disasters – to be produced by local residents; and an art contest for students.

Speeding on Jed Smith Road was discussed under agenda item #9, L.A. County Sheriff's Department.
