MEET GLORIA MOLLEDA, HIDDEN HILLS' NEW CITY MANAGER

The City of Hidden Hills is pleased to announce Gloria Molleda as its new City Manager. Gloria brings more than 25 years of public service experience, with over 18 years in executive leadership across Southern California. She is known for collaborative leadership, practical problem-solving, and a deep commitment to community service.

Gloria joined Hidden Hills in 2024 and has served in multiple capacities, including Assistant City Manager and Interim City Manager. In these roles, she oversaw day-to-day city operations, supported the City Council, and guided key initiatives and emergencies. Her recent work includes leading the City through the January 2025 fires and windstorm, strengthening CERT coordination and public-safety partnerships, advancing major capital projects such as the Mureau Road/Round Meadow landscape improvements, and helping complete adoption of the 2021-2029 Housing Element.

Prior to Hidden Hills, Gloria served as City Manager of Rosemead, managing a \$35 million budget, securing more than \$27 million in transportation and safety funding, and partnering on Senate Bill 1307 to unlock new resources for local infrastructure—achievements that reflect her ability to deliver results while building strong regional and intergovernmental collaborations.

As City Manager, Gloria will focus on maintaining Hidden Hills' exceptional quality of life, advancing infrastructure and safety projects, strengthening emergency preparedness, and enhancing transparent, responsive customer service. She looks forward to partnering with residents, Council, and regional agencies to support a resilient, well-run city that reflects the community's values.



WATCH THE PUBLIC SAFETY TOWN HALL RECORDING

City Council Updates

At the Council's Regular Meeting on October 13, 2025, the City Council held a Public Hearing on Variance Application No. V-387 for a new residential home on Hilltop Road to encroach 21'4" into the front yard setback (setback of 28'8" in lieu of the required 50' front yard setback), and for an existing retaining wall to encroach 25' into the side yard setback, in lieu of the required 25' side yard setback. Following discussion, the Public Hearing was continued to the November Council Meeting, where Council accepted public testimony and approved the ordinance subject to conditions.

The City's legal firm, Best Best & Krieger, then provided an informational update regarding the proposed cemetery project located just outside city limits in the City of Los Angeles. YOU
BURN**

November marks the beginning of South Coast AQMD's annual Check Before You Burn season. Now through the end of February, residents are asked to check before burning wood in their fireplaces to limit emissions of fine particulate matter (PM2.5).

A No-Burn day is a 24-hour ban on wood-burning in residential fireplaces, stoves or outdoor fire pits in the South Coast Air Basin. South Coast AQMD forecasters call for residential No-Burn Days when PM2.5 is expected to reach unhealthy levels due to air emissions and stagnant weather conditions.

Short-term exposure to PM2.5 can cause throat and eye irritation, aggravate asthma, and trigger other respiratory or cardiovascular health problems. Prolonged exposure to high levels of PM2.5 may increase the risk of strokes, heart attacks and cancers. Young children, older adults, people with lung or heart diseases, people who are pregnant, and those who spend a lot of time outdoors are especially vulnerable to the health effects of PM2.5. Burning wood contributes to poor indoor air quality and poor air quality in surrounding neighborhoods. Gas and other non-wood burning fireplaces are also exempt.
