

## NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN THAT the Hidden Hills City Council will conduct a public hearing to consider the following:

"AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HIDDEN HILLS ADOPTING BY REFERENCE PART 2 OF TITLE 24 OF THE CALIFORNIA CODE OF REGULATIONS, COMPRISING THE 2025 CALIFORNIA BUILDING CODE; PART 2.5 OF TITLE 24 OF THE CALIFORNIA CODE OF REGULATIONS, COMPRISING THE 2025 CALIFORNIA RESIDENTIAL CODE; PART 3 OF TITLE 24 OF THE CALIFORNIA CODE OF REGULATIONS, COMPRISING THE 2025 CALIFORNIA ELECTRICAL CODE; PART 4 OF TITLE 24 OF THE CALIFORNIA CODE OF REGULATIONS, COMPRISING THE 2025 CALIFORNIA MECHANICAL CODE; PART 5 OF TITLE 24 OF THE CALIFORNIA CODE OF REGULATIONS, COMPRISING THE 2025 CALIFORNIA PLUMBING CODE; PART 7 OF TITLE 24 OF THE CALIFORNIA CODE OF REGULATIONS, COMPRISING THE 2025 CALIFORNIA WILDLAND-URBAN INTERFACE CODE; PART 11 OF TITLE 24 OF THE CALIFORNIA CODE OF REGULATIONS, COMPRISING THE 2025 CALIFORNIA GREEN BUILDING STANDARDS CODE; THE 2024 EDITION OF THE INTERNATIONAL PROPERTY MAINTENANCE CODE AND AMENDING TITLE 5 OF THE HIDDEN HILLS MUNICIPAL CODE" by title only, waive further reading and introduce the Ordinance." This proposed item adopts by reference the California Building Standards Code and Amending Chapter 5-5 of Title 5 of the Hidden Hills Municipal Code.

A public hearing will be held on **Monday, November 10, 2025, at 5:30 p.m.,** or as soon thereafter as is possible in the Council Chambers of the City Hall, 6165 Spring Valley Road, Hidden Hills, California 91302. Members of the public may also participate via electronic means as specified below.

At the public hearing, the City Council will hear and consider all comments. All interested persons are invited to attend and speak on this matter.
