CALL TO ORDER AND PLEDGE OF ALLEGIANCE

A regular meeting of the City Council of the City of Hidden Hills was duly held in the Council Chambers at the City Hall, 6165 Spring Valley Road, Hidden Hills, California 91302 on Monday, April 27, 2009 at the hour of 7:30 p.m. Mayor Steve Freedland called the meeting to order and presided thereover after leading the Council and audience in the Pledge of Allegiance.

Upon MOTION of Council Member Fisher, seconded by Council Member Siegel and unanimously carried, it was resolved that the agenda for the April 27, 2009 regular meeting be approved as submitted.

PUBLIC SAFETY

A. Los Angeles County Fire Department Report - March

Community Services Representative Maria Grycan provided the following report:

During the month of March there were a total of 12 calls, including 6 false alarm/good intent, 3 medical, 1 public assist (invalid), 1 public service (with no details available), and 1 hazardous condition with no fire (arcing wires shorted electrical equipment); 1 station inspection occurred, along with 4 Fire Prevention Bureau inspections; all fire hydrant inspections have been completed; no plans were checked; in addition a Station tour was provided for twelve people, and CERT training was completed with a final drill at the Hidden Hills City Hall with those from both the Hidden Hills and Agoura Hills CERT classes participating; as a reminder, the brush clearance deadline for improved properties is May 1st, with inspections to start around the middle or end of May.

In response to Mayor Freedland, Ms. Grycan said the Department is starting to get more calls about rattlesnakes, as they are looking for water.

B. Los Angeles County Sheriff's Department Report - March

The following report was presented by the City's liaison Lt. John Benedict:

There was one grand theft during the month of March in the 24400 block of Little Hollow, with an Ipod and two faucets taken from the location; even though the number of crimes is very low in this City, it is still very significant that the first quarter has shown a 63% reduction in crime; five false alarms occurred during the month; in relation to traffic, there were no collisions, but 42 citations were issued; 34 of those were hazardous, 4 non-hazardous, and 4 parking; one dangerous driver in Hidden Hills was reported to STTOP, while another Hidden Hills resident was reported for a violation in Calabasas; both drivers were contacted and warned.
