MINUTES

1. CALL TO ORDER

The July 26, 2005 regular meeting was called to order at 7:55 p.m. by Chairman Jim Doran.

3. APPROVAL OF AGENDA

The agenda for the July 26, 2005 regular meeting was approved as submitted.

4. APPROVAL OF MINUTES

The minutes of the June 28, 2005 regular meeting were tabled and will be addressed at the next meeting.

5. AUDIENCE

There were no comments at this time.

6. L.A. COUNTY SHERIFF'S DEPARTMENT

Activity report for June was received and reviewed. It was noted that the motorcycle officers write substantially more citations than other deputies. Staff will be asked to obtain information regarding the differences between citation numbers W27315D and 27351E, and also citation numbers 22454 and 22454A. Golf carts were discussed, an issue the City Council has also addressed. Commissioners were asked to monitor golf cart use and report any illegal activity to staff.

7. L.A. COUNTY FIRE DEPARTMENT

Activity report for June was received and discussed. Staff will be asked if the hydrant inspections include the hydrant on Bill Cody Road.

8. L.A. COUNTY ANIMAL CONTROL

Activity report for June was received and discussed.

9. BUDGET

The proposed Public Safety budget was approved by the City Council in conjunction with approval of the City's 2005-06 budget.

10. OLD BUSINESS

A. Emergency Services Grants – Update

Chairman Doran is compiling a list of suggestions for the computers and will get final quotes after these are completed. The T-1 line has been installed, with the invoice to include 12 months of service for grant submittal. He is also finalizing the ID cards.

B. Traffic Calming Device – Update

Commissioner Nussbaum reported on his data collection and analysis of the Traffic Calming Device located on Round Meadow Road. The 85% is 35 mph. There was no base line established to start this study. The Commissioners felt

this report should be provided to the Sheriff. Commissioner Nussbaum will obtain costs for moving this device to another location. The other locations discussed were on Long Valley Road near 24300 Long Valley and near 5824 Jed Smith Road. Commissioner Nussbaum was thanked for the work he has done on this report and project.

C. Flow of Traffic at Round Meadow Elementary School

The flow of traffic at Round Meadow Elementary School will be addressed after school starts.

D. Road Checks by Commissioners

Chairman Doran will send copies to the Commissioners of their areas and ask them to bring their reports to the September meeting.

11. EMERGENCY SERVICES

CERT classes will be given in Agoura Hills starting on September 13 for eight (8) weeks. Chairman Doran asked the Commissioners to ask friends, neighbors, etc. if they would like to become a member of the City's Neighborhood Emergency Assistance Team (NEAT). The Commissioners discussed ways to encourage participation. Commissioner Nussbaum will work on involving older teenagers, while Commissioner Falotico will approach other walkers and seniors, with a report from each to be provided to Deputy City Clerk Deana Graybill for inclusion on a future agenda.
