1. <u>CALL TO ORDER</u>

3. <u>APPROVAL OF AGENDA</u>

The agenda for the April 25, 2006 regular meeting was approved as submitted.

4. <u>APPROVAL OF MINUTES</u>

The minutes of the March 28, 2006 regular meeting were approved as submitted.

5. <u>AUDIENCE</u>

There were no comments at this time.

6. BUDGET

The Commission will be spending budget funds soon.

7. <u>L.A. COUNTY ANIMAL CONTROL</u>

Activity report for March was received and discussed.

8. <u>L.A. COUNTY FIRE DEPARTMENT</u>

Activity report for March was received and discussed. It was noted that Westmed will be the new ambulance service within the City.

9. <u>L.A. COUNTY SHERIFF'S DEPARTMENT</u>

Activity report for March was received and discussed. There was a large number of citations given. It was noted that there was one call for domestic violence which is still being investigated. The STTOP camp has been cancelled for this summer due to a lack of deputies. There were two letters written to residents regarding traffic problems.

10. EMERGENCY SERVICES

A. Disaster Area B Issues

There is a lot of training that must be completed. Chairman Doran met with the representative from Malibu and they decided on the training be presented, which must be completed prior to September 30, 2006. Chairman Doran asked the Commissioners to make a list of what they believe is needed for various disasters, i.e. earthquake, floods, etc. This list will be discussed at a tabletop training exercise on May 20th at 8:00a.m. Chairman Doran distributed a letter sent by the City of Malibu to all that City's residents requesting information for CAN. It was suggested that a similar letter be sent to Hidden Hills residents requesting the home phone and two cell phone numbers. Residents will mail the information directly to CAN. All of this will be explained in an upcoming newsletter. When Chairman Doran is not available, someone else needs to serve as the City's public information officer. This will be discussed with the City Manager. Commissioners Falotico and Weber were recently reappointed to the Commission

by the City Council. Bird flu and anthrax vaccines were discussed. Chairman Doran distributed a list of medical personal within the City. Any additions or corrections to this list should be given to Deputy City Clerk Deana Graybill.

B. Continued Discussion Regarding Automated External Defibrillator (AED) for City Hall

The City is covered for liability for its use of an AED by trained personnel. Chairman Doran has requested information on this machine from four companies.

C. Discussion Regarding Southern California Edison's Rotating Outage Procedures and Policies

Southern California Edison will notify the City when there is to be a rolling blackout.
