Announcements will also be made at upcoming City Council meetings. Commissioner Ulrich will contact others in an attempt to obtain new members.

At least 15 people need to commit to the new CERT class starting in April or the class will be canceled. Public Safety Commissioners and CERT members need to keep track of their volunteer hours to be reported to Area B. Backpacks will need to be purchased for new CERT members, and once they complete the classes, it may be possible to provide jackets for both old and new CERT members.
