1. <u>CALL TO ORDER</u>

Resident Eugene Wolver was present. Mr. Wolver pointed out that there are two types of stallions, breed and parade. The breed stallions can be more of a problem, and to his knowledge there haven't been problems with stallions in parades.

Therefore, he believed stallions should be allowed in the Hidden Hills Fiesta parade. Commissioner Nussbaum noted that he talked with the Hidden Hills Horsemen to obtain their input on this matter. After those discussions, the Hidden Hills Horsemen provided a letter dated March 5, 2013 which recommended against allowing stallions in the Fiesta parade. Commissioner Nussbaum also spoke to others and conducted extensive additional research as well, resulting in his personal belief that it probably is not a good idea to have stallions in a small home town parade, such as the Hidden Hills Fiesta parade, with all the distractions that can occur. After further discussion, upon MOTION of Commissioner Zane, seconded by Commissioner Ulrich and unanimously carried, it was resolved to accept the recommendation of the Hidden Hills Horsemen to not allow stallions in the Fiesta Parade, and make that same recommendation to the City Council.

B. Review of Amendment to the Agreement for School Crossing Guard Services from All City Management Services and Recommendation to City Council

This item was continued to the April meeting.

C. Interview of Candidates for the Public Safety Commission and Recommendation to the City Council
