**10. OLD BUSINESS**

**A. Retention of an Emergency Services Coordinator Part-Time Consultant – Update**

A total of six (6) consultants were interviewed by the panel consisting of representatives from the Fire and Sheriff's Department, Emergency Services Director Gabe Nussbaum, the Area B DMAC, and the Emergency Services Supervisor from Santa Clarita. An independent consultant agreement will be offered to Chris Sundlee, with a proposed start date of June 1, 2014 if the contract is approved by the City Council and all required insurance documents are provided by Mr. Sundlee.

**B. Consideration of Rate increase for the 2014-2015 School Year for School Crossing Guard Services from All City Management Services and Recommendation to City Council**

All City Management is asking for a rate increase from \$15.72/hr to \$17.78/hr. If accepted, they will commit to a price freeze for the next four (4) years. Upon MOTION of Commissioner Zane, seconded by Commissioner Ulrich, and unanimously carried, it was resolved to recommend to the City Council approval of the Amendment to Agreement between All City Management Services, Inc. and the City of Hidden Hills for Providing School Crossing Guard Services at Round Meadow School for the fiscal year beginning July 1, 2014 through June 30, 2015 at a cost of not-to-exceed \$33,604.20, based on three crossing guards working a total of 10.5 hours/day for 180 school days at \$17.78 per hour.
