10. NEW BUSINESS

A. 2018 Fiesta – September 29th

Emergency Services Coordinator Kevin Ryan reported that the Emergency Services Trailer will be present again at the fiesta. It was suggested that sign-ups for CPR and CERT be placed at the Fiesta. Commissioner Treacy will follow up on these lists. Also noted that a golf cart will be used to assist handicapped residents coming to the evening festivities at the Fiesta.

B. Discussion Regarding Halloween

Things are in place as in the past. Golf carts will be allowed on Wingfield and Round Meadow. Suggested putting a light at the end of Wingfield. Covered 6 Security will be asked to come to the next meeting.

C. Miscellaneous

Mr. Ryan has contacted the state to get city-wide alerts for emergencies for all cell phones in the city. Southern California Edison is implementing Public Safety Power Shutoff (PSPS) which is a practice of last resort which entails de-energization to prevent wildfire ignitions if windy with possible fire implications. PSPS timeline for customers includes a first notification 2 days ahead, second notification 1 day ahead, third notification of power shutoff, and fourth notification when power is restored.
